Any other forums or exhibitions related to the metal industry, aside from "Asia Copper Week," are not associated with Center for Copper and Mining Studies (CESCO) and China Non-Ferrous Metals Industrial Association (CNIA), or the Executive Committee of "Asia Copper Week."

2. "Asia Copper Week" operates independently, and relevant information is released through official channels.

"Asia Copper Week" is an exclusive, official international exchange platform jointly established by Center for Copper and Mining Studies (CESCO) and China Non-Ferrous Metals Industrial Association (CNIA). Any actions, whether implied or
